Preparation

1. Heat phase A to approx. 80°C.
2. Homogenise phase B.
3. Heat phase B to approx. 80°C, too.
4. Add phase B to phase A and homogenise.
5. Cool down with gentle stirring.
6. Add phase C below 30°C.
7. Homogenise for a short time.
