#### Processing

Add all ingredients of phase A in a vessel while stirring and heating to 75°C until uniform. Heat phase B to 80°C and mix until uniform. Transfer phase B to phase A under stirring. Homogenize. Start to cool down under continuous mixing. Below 30°C check pH. If necessary adjust pH to 6.5-7.0 with Sodium Hydroxide (10% sol.). Add phase C and check pH again. If necessary adjust pH to 6.5-7.0 with Sodium Hydroxide (10% sol.). Mix to room temperature until uniform.
